## Jefferson County “Little Miss” contest rules and regulations

1. Contest will be Wednesday, June 23, 2021 at 6pm in the Jefferson County Fairgrounds. Interviews will be on June 23<sup>rd</sup> also in the morning in the Cambridge Building on the fairgrounds. (We will notify you of any changes in location.) Each contestant will have a 10-minute interview with the judges. Contestant’s interview times assigned when registration ends.
2. Little Miss contestant must pre-register at the Jefferson County Extension Office. Entry fee of \$25.00 (sponsors optional) payable to the Jefferson County Fair Board and copy of the contestant’s birth certificate must accompany the entry form. Deadline is June 11, 2021. No exceptions. Open to the first 12 registrants who turned in completed application, registration fee and copy of birth certificate.
3. Interview judging based on poise, personality, dressing in accordance with theme, overall presentation and response to question.
4. Any contestant who has performed or competed at a professional level (for monetary gain) in anything other than amateur contests considered ineligible.
5. All contestants must be a resident of Jefferson County for at least 1 year or be a member of a Jefferson County 4H Clover Club. 6. Contestants may not be older than 9 years of age or younger than 6 years of age by June 1, 2021.
6. Parents and /or chaperones not allowed into the interview room or the backstage area before or during the contest. Assigned staff will assist contestants if needed.
7. There will be an on stage question for contestant along with a presentation to present the winners of the contest.
8. Winner and 1st Runner Up will need to be available to help hand out ribbons at assigned fair shows during the 2021 Jefferson County Fair. Each contestant will receive a participation gift.
9. There is no “theme” this year. No pageant dresses or swimwear allowed. Contestants should dress for a day at the fair as a Little Miss. Contestants allowed to wear long dresses, skirts, jeans/shorts. Contestants will need to be dressed in this manner for the interviews and the evening question and presentation.
10. Contest is limited to the first 12 registrants turned into the Extension Office and no less than 5 contestants.
11. Any contestant who has won the title “Little Miss” at the Jefferson County Fair in the past is unable to compete in the contest.
12. Any arguments about final decisions will be grounds for immediate disqualification. Judges decisions are final.
