Jefferson County “Little Miss” Contest Rules and Regulations

1. Contest will be **Wednesday, June 25th, 2025 at 7:00 pm in the Jefferson County Fairgrounds.** **Interviews will be conducted mid-morning on June 25th** in the Cambridge Building on the fairgrounds. (We will notify you of any changes in location.) Each contestant will have a 10-minute interview with the judges. Contestant’s interview times will be assigned when registration ends.
2. Little Miss contestants must pre-register at the Jefferson County Extension Office. **Entry fee of \$35.00** (sponsors optional) payable to the Jefferson County Fair Board, and a copy of the contestant’s **birth certificate must accompany the entry form. Deadline is May 30th, 2025.** No exceptions. Open to the first 12 registrants who turned in completed application, registration fee, and copy of birth certificate.
3. Interview judging is based on demeanor, personality, poise, response to questions, and overall presentation.
4. Any contestant who has performed or competed at a professional level (for monetary gain) in anything other than amateur contests considered ineligible.
5. All contestants must be a resident of Jefferson County for at least 1 year or be a member of a Jefferson County 4 H Clover Club.
6. **Contestants may not be older than 8 years of age or younger than 6 years of age by June 1, 2025.**
7. Parents and/or chaperones are not allowed into the interview room or the backstage area before or during the contest. Assigned staff will assist contestants if needed.
8. There will be an on stage question for contestants along with a presentation to present the winners of the contest.
9. The crowned Little Miss and 1st Runner Up will need to be available to help hand out ribbons at assigned fair shows during the 2025 Jefferson County Fair. Each contestant will receive a participation gift.
10. There is no “theme” this year. No pageant dresses or swimwear allowed. Contestants should dress for a day at the fair as a Little Miss. Contestants are allowed to wear long dresses, skirts, jeans/shorts. Contestants will need to be dressed in this manner for the interviews, the evening question, and the award presentation.
11. Contest is limited to the first 12 registrants turned into the Extension Office, and no less than 5 contestants.
12. Any contestant who has won the title “Little Miss” at the Jefferson County Fair in the past is unable to compete in the contest.
13. Any arguments about final decisions will be grounds for immediate disqualification. Judges’ decisions are final.
14. By allowing your daughter to compete in the Little Miss Contest, you are providing consent for the Greater Jefferson County Fair to use photos of the competition for promotional purposes.
